Organizational Update: Transitioning with Purpose



Shaping the Future: Board Decisions You Should Know



Board Term Length Extended

Board members and officers will now serve for two years instead of one, including the current board.

As part of this year's theme, *Navigating Change*, CVHEG has taken a deliberate step toward strengthening the sustainability and continuity of our leadership structure by extending leadership terms from 12 to 24 months. This decision was made after careful consideration of the challenges associated with frequent role transitions and the opportunities that come with greater consistency.

A two-year term provides leaders the opportunity to move beyond the initial learning curve and into a phase of deeper engagement and strategic execution. In the first year, leaders can focus on building relationships, gaining a comprehensive understanding of operations, and setting meaningful goals. The second year allows them to fully implement initiatives, refine strategies, and see the results of their efforts. This continuity not only benefits individual leaders but also the organization as a whole, ensuring that important work is carried forward without disruption.

By reducing the frequency of leadership transitions, we are creating a more standardized approach to these roles - one that strengthens institutional knowledge, fosters greater consistency, and establishes a clearer framework for succession planning. This adjustment aligns directly with our commitment to advancing CVHEG in a sustainable way, enabling us to maintain progress, enhance collaboration, and achieve lasting impact.

We are confident this change will help CVHEG navigate transitions more effectively, foster stronger leadership development, and position our organization for continued success in the years ahead.

President - Elect






